Commencing September 1st of each year and terminating as early as April 15, (weather permitting) of the next year. Removal must be completed prior to the May long weekend.

Rental rates shall be a flat rate of \$50.00 per month for units up to 20 feet, plus \$2.00 per foot for units exceeding 20 feet. This measurement is from bumper to bumper or hitch to prop, whichever applies. GST will be added to this rate.

The PRINCE ALBERT EXHIBITION will attempt to meet the requests for removal of the units by the RENTERS, but failure to do so will not affect the rental charges. Rent will be charged per month and per day for the full term of the storage.

If the item stored is a boat and motor, the RENTER agrees that the gasoline tank will be removed from the boat at the time of storage and that the gasoline will be drained from the motor. All propane tanks are to be removed from camper trailers.

The RENTER further agrees that the PRINCE ALBERT EXHIBITION Incorporation is in no way responsible for the safety of the stored item(s), nor is responsible for any damage incurred during the rental period.

FOR THE ENTIRETY OF THIS AGREEMENT IT IS THE RESPONSIBILITY OF THE RENTER TO PROPERLY INSURE THE ITEM(S) BEING STORED. THE RENTER IS REQUIRED AS A CONDITION OF THIS AGREEMENT, TO PROVIDE THE PRINCE ALBERT EXHIBITION WITH A CERTIFICATE OF INSURANCE, CONFIRMING THAT INSURANCE COVERAGE IS IN EFFECT FOR THE DURATION OF THE STORAGE PERIOD ON EACH AND EVERY ITEM BEING STORED. FAILURE TO PROVIDE THE REQUIRED DOCUMENTATION WILL FORFEIT ANY RESPONSIBILITY AND LIABILITY OF THE PRINCE ALBERT EXHIBITION INCORPORATION.
